The Harker Heights Parks and Recreation Department offers sports leagues, programs, classes, and events for families of all types and ages. Your sponsorship matters by making a difference in our community by ensuring that our programs are high quality and accessible to all.

What is Sponsorship? How is it different from a donation?

"Sponsorship" typically means a person or entity provides the City with financial support for an activity, City program, or City facility typically in exchange for the City providing more than nominal recognition of that financial support. This overt recognition distinguishes a sponsorship from a donation. Financial assistance provided by a sponsor may consist of cash and/or in-kind contributions.

How will my Sponsorship be used?

Your sponsorship may be used for, but is not limited to, the purchase of event components, league uniforms/equipment, advertisements, and even scholarships for residents who would be excluded from participating because they lack the funds to do so. Sponsors may but are not required to be informed of how the sponsorship was used when deemed appropriate by the City.

What are the City's responsibilities regarding the sponsored event or item?

The City has both legal and procedural obligations to sponsors. All revenue, products, donations, sponsorships, and services received from donors and sponsors by the City of Harker Heights, shall be recorded and maintained.

A record of all sponsorships and donations including name, type, contact name if a company, and amount of sponsorship shall be kept up-to-date and accurate by both the receiving department and the Finance Department according to the City's Policy.

The integrity and credibility of the City shall be the overriding consideration in all advertising and sponsorship activities. The City possess sole and final decision-making authority for determining the appropriateness of a sponsorship relationship and reserves the right to refuse any offer of sponsorship including but not limited to, products of drugs, tobacco, weapons, gambling, products/services that violate City policy or mimic the identity programs of Harker Heights Parks & Recreation.

Sponsor's Right of First Refusal

The City intends to host future events and provide additional opportunities for sponsorship. However, the city is under no obligation to host any future events. In recognition of a Sponsor's support of events, the City grants Sponsors the right of first refusal over all other potential sponsors for the same sponsorship of the same event, in the subsequent year. Sponsorships available for rights of first refusal are outlined in the package's benefits on previous pages. Sponsors have sixty (60) days following the conclusion of the sponsored event to elect to renew its sponsorship for the following year. If Sponsor fails to notify the City of its intentions to renew its sponsorship within the sixty (60) days period, the City reserves the right to open the sponsorship opportunity to the public without providing prior notice to the Sponsor.

Liability for the content of sponsorships (text, representation, and illustrations) is assumed by sponsoring agencies for any claims arising there from against the City. Right of refusal of any sponsorship not in keeping with the agency's terms and policies is reserved by the City. The City is not liable for delays in delivery, and/or non-delivery in the event of an Act of God, action by any governmental or quasi-governmental entity, fire, flood, insurrection, riot explosion, embargo, strikes (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slowdown, or any condition beyond the control of the City affecting production or delivery in any manner.
